Green Supers Program: M&V

2010-2012: Green Supers Program

- Trained 2,000 MF building operators in 2 years
- Supers created a Green Building Plan
- Tracked changes operators made in their building

Steven Winters - Measurement & Verification

- Benchmarked 43 buildings and conducted 38 superintendent interviews - 92% of the superintendent's implemented ECMs in buildings as a result of the Program
- Energy savings between 1 14%



Scenario #1: In the Process of a Building Project

- Include the building operator/s into the conversation - Please include building operators in the integrated process
- Include training in your proposal
- Train the staff/building operators and possibly the board (i.e. sit down or coaching method)
- If focused on building products Offer training on how to use/maintain your products properly to building operators



Scenario #2: In the Process of a 32BJ Building Project

- Share that you heard about free training at 32BJ
- Communicate with 32BJ Training Fund
 - If there are 7-10 eligible 32BJ members, can do customized and/or on-site training
 - Note: If working on a LEED or WELL building project – training can help you earn a point
- In your building or on your board:
 - Encourage operators to take training
 - Set aside a small stipend for training
 - Supers Tour
 - Green Welcome Packet



Scenario #3: In the Process of a Non-32BJ Building Project

- Communicate/Collaborate with other organizations that offer training
 - Urban Green Council
 - CUNY Building Performance Lab (BPL)
- If working with the City
 - Dept. of Citywide Administrative Services (DCAS) – Energy Management
 - CUNY BPL


